The International Kungfu Council in the world organization has been working honestly for many years established in India. This Rulebook is for coaches only. It also reflects the official IKCkungfu Championship Rules. These current rules are valid for all member states. Consideration can be given to local legal requirements and obligations if required. The official language is English. This Rulebook can be translated in to other languages by the IKC office permeation. In case of any discrepancies, the official English version shall prevail. Without the specific written consent in English or in Hindi, this Rulebook shall not be copied, published or distributed. This includes electronic, digital, physical or any other duplication forms. # TIME OF FORMATION

All creative sections are permitted no more than thirty second introductions. This time starts from the first foot on the mat.

The minimum time allowed for all creative Forms is 1 minute, maximum of 2 minutes. This time will begin from the first move after the Judges have given permission to begin. If the time be over/under in any part, a deduction of 0.5 marks will be made from the Form by all Judges.

# **IKCKUNGFU**

A participant can do any events of his choice. The moves within the Form must be appropriate to the Style being performed. Techniques should be performed with full power, focus and explosiveness. When executing the form all kung fu Techniques should be performed logically and be relative to the selected Form. The Participation's name, the name of the form and association or country, the name of the event that will be closed must be told to the Judge. In trail sections no 10 participate will qualify for the final, and will perform again in reverse order. It is optional at National level that the winner can be decided after only one round. In all World level competitions, wherever rankings are available, heats must be seeded. A judge for forms must have martial arts background, and be a minimum 3rd Dan Black Belt IKCkungfu or other Martial Arts. It is at the host country's discretion i.e. the promoter, to decide if mats are to be used on the area or not. Valid International Kungfu Council forms like Kung fu or Traditional kungfu are listed on the official IKCkungfu selected listing of official IKCkungfu India Long Form, Long Stick style and Traditional kungfu Forms" All creative forms with music, Open Hand and weapons, events that do not exist will be canceled. Any traditional form must be announced according the style. For example Traditional Kungfu, Kung fu Eagle Claw, Tiger Claw, Money, Drunken Boxing Your own choice and weapons must do with music.

# **JUGDES POSITION**

#### POSITION

A chief judge and tow assistant judges will site at the front table, the time keeper on the left and register on the right will sit, on the left side and right side of the ground, one by one judge will sit, extra will have a videographer and a medical team compulsory. Note: Four A great judges will sit in the back office and observe the championship event and give the number that will be the final.

## SCORING


Every judge will have a 10 point in hand, 1<sup>st</sup> One Gold Medal if you get 9 out of 10, 2<sup>nd</sup> One Silver Medal if you get 8 out of 10, 3<sup>rd</sup> One Bronze Medal if you get 7 out of 10,

## DRAW

In the case of a draw the competitors will be asked to repeat same form again, the higher score wins. In case of a draw again the judges decide by hand evaluation.

#### Notes:

- In the front seat of the arena, one chief judge 2 assistant judges 1 time keeper and 1 registration will sit. Three will be three side judges and one center referee, and one medical team and four video camera.
- IKCkungfu International arena size 8 metre by 6 metre and safety zone will be around 2 feet, must be 2.5 feet height from the bottom.
- Everyone should be seated in the same way as given in the arena picture
- 1<sup>st</sup> one chief judge, tow assistant judges time keeper and registers will sit at the official table. There will be Left side camera men right side video camera men. 1 and 2 side judges sit.

# **ROUND FORMAT**

#### TRIAL ROUND - TR

Each participant must be given a trial (empty hand and weapons), the players who get 6 or more number will go to the 1<sup>st</sup> round, those who get 7 or more number will go to the 2<sup>nd</sup> round, those who get 8 or more number will go to the 3<sup>rd</sup> round and top 10 participants will go to the next round.

#### **QUALIFIED ROUND - QR**

Top 10 participants from the trial round will play in the qualifying round. Those who get number 8 in the qualifying round (through-out 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> round) will be able to play in the division round for the medal. Top 4 participants will be selected from the qualifying round.

#### **DIVISION ROUND - DR**

Top 4 participants from the qualifying round will play in the division round. Top scorer will get Gold Medal, 2<sup>nd</sup> top scorer will get Silver Medal and 3<sup>rd</sup> top scorer will get Bronze Medal.

#### **TALENT ROUND - TR**

The talent event is the founding Event of the International Kungfu Council. It will be revised again, in this event, all style kungfu form and traditional kungfu event will be able to show any of his talents. The Talent Event will be only 1 round where 9 plus number will get Gold Medal, 8 plus number will get Silver Medal and 7 plus number will get Bronze Medal.

# **UNIFROM ONLY EVENT**

# **IKCkungfu Championship Dress code**

The competitor must wear an IKCkungfu Event only IKCkungfu recognized uniform and Shoaling kungfu Uniform. There is no club T-shirts. The uniform must be clean and pressed, Belt of appropriate grade must be worn, and no jeweler and costumes may be used. The Competitor must announce Style, Club or Country, according to whether competition is National or International. The Competitor must show good etiquette at all times in the presentation, performance or application of Taolu, or Form Weapons.

# **ETIQUETTE**

While on or around the mat the competitor should show respect and discipline at all times. Respect must be shown to the other competitors. Expected mat etiquette will consist of the Competitor bowing upon entering the competition area and approaching the Judges. The Competitor should perform the introduction – see General rules. Competitor should then ask for permission to begin, bow to the judges and get ready to begin the Form.

Competitor must show IKCkungfu discipline at all times. They must maintain focus and concentration on what they are doing. Upon completion of the Form, the Competitor should wait for the Judges' permission to leave the floor

# TREDITIOAL KUNGFU FORM

The source is martial arts gymnastic type moves are permissible, provided that they are within the style for **TKF** but they must be, Practical and form part of that style. An adaptation is acceptable if added moves are traditional style, being performed. A traditional uniform must be worn. There will be no use of weapons. Music is allowed. There is a two minute maximum time limit. A Timekeeper will be appointed. A creative form is not acceptable. When Scoring, Judges should be looking for: good flowing Techniques, Stances, Punches, Kicks executed with balance, Blocks, Balance, Strength, Focus and good transition between moves.

# ALL STLY KUNGFU FORM

The source is Indian martial arts development by chain gymnastic type moves are permissible, provided that they are within the style for kungfu but they must be, Practical and form part of that style. An adaptation is acceptable if added moves are traditional style, being performed. Traditional form animal arts, drunken boxing, any styles own choose. There will be no use of weapons only bear hand. Music is allowed. There is a two minute maximum time limit. A Timekeeper will be appointed. A creative form is not acceptable. When Scoring, Judges should be looking for: good flowing Techniques, Stances, Punches, Kicks executed with balance, Blocks, Balance, Strength, Focus and good transition between moves.

#### **CREATIVE FORM**

Creative forms are: Freestyle forms with music, with and without weapons, and Creative forms no music, with and without weapons. In the result of a draw for first second or third, the Form will be repeated again and scored between the two competitors who have tied. Highest score will win the tied position. In the result of a second tie, Judges will show hands. Competitor performing a Form must express a mentally and physically realistic approach to the various Imaginary opponents in their form. Techniques should be performed where necessary with full power, focus and Explosiveness. When executing the Form, all basic techniques must be performed logically. Kiai's or shouts should be included in a form but not on every single move. Judges will be looking for basic techniques, stances, speed and cleanness of execution. Tricks or gymnastics whilst being high risk and high difficulty must be performed with accuracy throughout. A Form should be fluid and Continuous, time spent standing still should be kept to a minimum. All aspects of the person's physical ability will Be taken in to account, such as flexibility, strength, speed, stamina and attitude. Creativeness is encouraged and high risk moves and combinations will score highly if executed without fault. Weapons forms will be scored primarily on the weapon usage. Manipulation and creativity with the weapon should be your main focus during a weapons form. The weapon cannot be left unattended once a form has begun.

#### **PROTEST CRITERIA**

A decision rendered at the termination of any forms contest is final, and cannot be changed unless the IKCkungfu Representative at the event determines that any one of the following occurred: There was collusion affecting the results of any category. There was a clear violation of the rules or regulation governing IKCkungfu Form rules book which affected the result of any category. The adding of the points is incorrect. If the IKCkungfu Supervisor or Commissioner determines that any of the above occurred with regard to any bout, then the decision rendered shall be changed as the IKCkungfu Representative or Commissioner may direct. All protests over the decision of a match shall be verbally registered only by the protesting Sportsman and / or his Coach to the IKCkungfu Supervisor or head referee prior to the end of the event. All protests must be received at the appropriate IKCkungfu office, in writing and accompanied by all pertinent evidence, no later than 10 days following the bout in question. No protest will be considered unless accompanied by the appropriate fee: Rupee 1200. - Any decision by the IKCkungfu Chairman is final. The standard for review is "clear" evidence which would justify a change of decision, or "clear" circumstances which in the best interest of the sport, would justify a change in decision. Any questions on the rules of the IKCkungfu should be directed to the attended IKCkungfu Chairman.
